- 1. Call to Order, Welcome, Invocation President Bender called the meeting to order at 6:30 p.m. and quorum was met. President Bender introduced Knox Proctor and the ex-officio attorney of the board and Barbara Jones from the Town of Cove City. Commissioner Kohr gave the invocation.
- 2. Adopt Agenda Jay Bender, President

President Bender requested to add a 2.a. New Member Acceptance to the agenda before approval.

Commissioner Cavanaugh motioned to accept amended agenda, seconded by Commissioner Heath, and motion was unanimously approved.

President Bender stated two new towns paid their membership dues that did not last year, making them new members.

1st Vice President Riggs motioned to approve new members, seconded by Commissioner Best and motion was unanimously approved.

Commissioner Heath motioned to approve consent agenda, seconded by Commissioner Prescott, and motion was unanimously approved.

4. Budget & Audit Committee Report – Shane Turney, Treasurer

- c. Budget Amendments Finance Director presented Budget Amendment 1 for approval. Preliminary Notification of Grant Award received from the Division of Aging Services for the ARPA (American Resue Plan Act) funding in the amount of \$2,739,754. Commissioner Emory motioned to approve Budget Amendment 1, seconded by Commissioner Prescott, and motion was unanimously approved.
- d. Committee information and recommendations Treasurer Turney requested the board to refund those communities that were involved with the 160D re-write with previous Executive Director. Previous Executive Director had no justification of distribution. Commissioner Prescott motioned to refund the local match, seconded by Commissioner Dowe, and motion was unanimously approved.

Treasurer Turney requested approval to pay final invoices for Audit & Legal services totaling of \$54,489.50. Finance Director Miller will split between fiscal years.

Commissioner Heath motioned to approve payment, seconded by Commissioner Dowe, and motion was unanimously approved.

Treasurer Turney stated that the previous Executive Director, gifted boxes of meals totaling \$21,000 to the Senior Centers to the Counties.

Treasurer Turney stated the previous Executive Director was suppose to do merit raises based on performance and did not complete the request. Budget & Audit recommends passing a 3% COLA. Commissioner Emory motioned to approve Budget & Audit recommendation, seconded by Commissioner Taylor, and motion was unanimously approved.

Finance Director asked for the Deputy Aging Director to be reinstated as a position. As a new Aging Director is in place it would be beneficial to have a checks & balance on the Aging side before going to Finance. Commissioner Kohr requested that the Board looks at the structure of



the COG and compare to other COG's across the state. Finance Director Miller stated she did that and most AAA are set up with a Deputy Director for the check and balance purpose.

Commissioner Robinson motioned to reinstated the Deputy Aging Director, seconded by Commissioner Best, and motion was unanimously approved.

Interim Executive Director Report Jay Bender stated he has been dealing with transition items, personnel matters, composing closed session minutes, meet with Lee Worsley to receive opinions on ECC, the Town of Beulaville Municipal Comparison Request, 2 public records request, ARPA funds packet, City of New Bern withdrew membership from the COG, meet with Jones County DSS Director, Closed the office on Aug 12 for deep cleaning due to employees testing positive for COVID, learned of a possible audit of RPO funds triggered by the transition, sent letter in support of Wayne County building a training facility.
