d. Committee information and recommendations — Treasurer Turney stated the Budget and Audit Committee reviewed the check register and financial statements in the meeting at 5:00 p.m. There are some local governments that did not pay their dues in Aging and RPO. The committee recommends to withhold funds until payment. Attorney Proctor suggested to talk with government agencies for guidance and to give staff flexibility to make decision.

Commissioner Taylor motioned for staff to seek guidance from federal and state government about withholding services until payment of funds and to give staff the right to make decision after guidance, seconded by Commissioner Best, and motion was unanimously approved.

5. Interim Executive Director Report – Tim Ware, Interim Executive Director
Interim Executive Director Ware thanked everyone for the welcome and stated the COG needs board guidance and leadership to continue to succeed. Mr. Ware gave a legislature update that they are closing in on the budget before short session and discussing a DOT reform. He put in place a COVID policy.

6. SERDI Proposal - *Tim Ware, Interim Executive Director*

Interim Executive Director Ware proposed a proposal from SERDI to help search for the way forward. The group will contact member governments to research what the region needs and how ECC can be a part of their success.

Commissioner Taylor motioned to approve proposal and seconded by Commissioner Heath. Discussion of the timeline and cost of the proposal and function of the Interim Executive Director and Board is during the process.

7. Closed Session – NCG.S. 43-318-11(a)(3)

Commissioner Riggs motioned to go into closed session per statute NC G.S. 43-318-11(a)(3), seconded by Commissioner Heath, and motion was unanimously approved.

The meeting returned to open session at approximately 8:13 p.m.

On motion duly made by Commissioner Robinson and seconded by Commissioner Wiggins, and duly amended on motion of Commissioner Heath seconded by Commissioner Robinson, the Board approved the proposed Memorandum of Understanding for a Strategic Assessment of the Future of the Eastern Carolina Council with the Southeast Regional Directors Institute, provided that the following references to the possible dissolution of ECC be deleted:

- The last paragraph on page 1;
- The last sentence of the second bullet on page 2; and
- The last clause in the final bullet on page 2.

Commissioner Riggs voted against the motion.
