Prior to calling the meeting to order, A.W. Grady provided an overview of the current Remote Legislative policies put in place by the state of North Carolina.

**Call to Order** – *Kyle DeHaven, Chair TCC, called the meeting to order at 9:30. Quorum was met.* 

## **1. Public Comment Period** – *No public was present to comment.*

## 2. ACTION: Approval of Minutes

Minutes of the November 19<sup>th</sup> meeting were attached and presented for approval. Harold Thomas made a motion to approve the November 19<sup>th</sup> minutes, second by Jerry Jones, unanimously approved.

## 3. ACTION: Update to TCC By-Laws

To provide consistency and clarity among boards and committees within the ECC, we have been asked to provide an update to our by-laws. The updated by-laws are presented for review.

Mickey Anderson reiterated the reasons for the update, A.W. Grady added who could answer any questions raised by committee members. George Futrelle asked that the term "authority" be removed from the Duplin County and Mt. Olive airports as they are governed by advisory boards. George Futrelle made a motion to approve the by-laws as amended, second by Harold Thomas, unanimously approved.

4. ACTION: STIP Projects H184396, H184398, and H149003 Reconsiderations The firm handling the scoring of these projects has asked that we consider a roundabout for H184396 and H184398. They have also asked that H149003 be submitted as a superstreet. The projects are presented for discussion with the committee. *Mickey Anderson explained that the changes in question would likely boost the score of these projects in P6.0, and that the original submissions be considered as alternatives should the projects receive funding. Elizabeth Stalls asked to see the projects and they were then shown on screen. Harold Thomas asked about the cost difference between turn lanes and roundabouts. Len White shared that a roundabout will cost approximately one million dollars and turn lanes could be between \$500,000 and \$1.5 million. Harold Thomas made a motion to recommend continuing with the projects as submitted, second by Elizabeth Stalls, unanimously approved.*

f. Aviation

Duplin County Update – George Futrelle told the board that the 20 Year Master Plan is approximately 1/3<sup>rd</sup> complete. They are constructing 2 12,000 square foot corporate hangars and just completed a \$2million T-Hangar project. Air traffic is almost back to normal.

Lenoir County Update – *Rick Barkes stated operations are back up. T-Hangar construction project should be completed by December.* 

Wayne County Update – Barbara Kornegay provided shared that Mount Olive is working on their ALP and in the process of purchasing property for expansion.

Laurence Bergman made a motion to adjourn, seconded by George Futrelle, unanimously approved.
