Amplifying Our Voices

The National Consumer Voice for Quality Long-Term Care celebrates the month of October as Resident Rights Month. This is a time to honor residents living in long-term care facilities and to acknowledge the importance of dignity and rights of all long-term care residents. This year's theme is **Amplify Our Voices.** The theme emphasizes the importance of having a community of long-term care residents come together to make their voices heard. Amplifying your voice means being outspoken about your preferences and choices, as well as sharing who you are and your experiences. Throughout October, Eastern Carolina Council Area Agency on Aging ombudsmen provided resident rights training to five long-term care facilities and conducted presentations to three Resident Councils. We encouraged residents to make their voices heard and for staff to support and honor the rights of the residents they serve.



In 1983, President Ronald Reagan designated November as National Alzheimer's Disease Awareness Month. During November, National Alzheimer's Disease Awareness Month aims to make the public more aware of the disease, the impact it has on our communities, and the impact it has on the individual, and their family members.

Alzheimer's Disease is the most common form of dementia among older adults. According to the Alzheimer's Association, there are more than 5.7 million people in the United States currently living with Alzheimer's. There are 180,000 individuals 65 years and older living with Alzheimer's in North Carolina. This number is expected to reach 210,000 by the year 2025.

Alzheimer's disease is the sixth leading cause of death in the United States. Individuals diagnosed with Alzheimer's disease live an average of four to eight years after diagnosis but can live as long as 20 years, depending on the individual's age, health, and progression of the disease. 

<u>New Historic Resilience Workshop</u> offered by UNC, School of Government, <u>Downtown New Bern, Dec. 7th 9:00-4:00 OR Online Dec. 14th 9:00-4:00;</u> course fee - \$25.

The goal of the workshop is to seek and find common ground between historic preservation, hazard mitigation, private ownership, and public regulation, which generally represent worlds that are sometimes in conflict, despite common goals. Attendees will participate through structured discussions, case study problems, and open dialogue.
