Future expansion of PACE Centers by Carolina SeniorCare will take place during the next several years in Lenoir, Craven, Jones, Onslow, Pamlico, and Carteret Counties. REGISTER FOR UNC, SCHOOL OF GOVERNMENT'S "PURCHASING AND CONTRACTING 101" CLASS HELD ON JAN. 9-10. As part of an existing partnership between the NC Association of Regional Councils of Government (NCARCOG) and the ncIMPACT Initiative at the UNC, School of Government, please come join us for a 2-day program (2-hour classes) on Purchasing / Contracting on January 9th and 10th from 9:00-11:00 AM. This online program fee is \$55.

This 4-hour program will cover the laws that local governments need to know when procuring and contracting utilizing local, state, and federal funds. Topics include: legal requirements for public contracts; competitive bidding requirements and exceptions; construction contracting; and hiring architects and engineers. This program is ideal for department heads and departmental employees, managers, attorneys, elected officials, and others who want/need to know the basic requirements for local government purchasing and contracting. ETHICS TRAINING FOR ELECTED OFFICIALS – WED. FEB. 21st, 6:00-9:00 PM. NC General Statute 160A-87 allows qualified individuals to conduct the training.
