### **UPCOMING FEMA GO ENHANCEMENTS PLANNED FOR** AUG.-SEPT. 2024. Grant Outcomes (GO) is FEMA's new platform

for submitting, approving, and managing FEMA grants. Below is a synopsis of enhancements GO is planning:

- Update investment budget structures to allow recipients to better meet program requirements.
- Allow FEMA reviewer to monitor subrecipient management costs across a grant.
- Allow recipient to monitor subrecipient management costs across a grant. Develop new functionality to support additional configurations for the direct grant programs within FEMA GO such as configurable recipient management cost limit calculation options, award acceptance deadline, payment request attachments, and whether FEMA can change the payment amount at time of review. Also includes some Bi-Annual Strategy Implementation Report (BSIR) enhancements identified post implementation.
- Reduce manual effort for programmatic administrative users to set up disaster funding
- opportunities in FEMA GO. Increase standardization of Environmental Historic Preservation (EHP) review process across pass-through programs by supporting reviews at amendment. Enable analysis of disaster program data.
- •
- Enable period of performance amendments for Building Resilient Infrastructure and Communities (BRIC) and Flood Mitigation Assistance (FMA), if they are not immediately transitioned over to the streamlined pass-through process.
- Extend FEMA GO closeout capabilities to pass-through programs.

The next FEMA Go Quarterly User Focus Group webinar is scheduled for Oct. 10<sup>th</sup>; more information will be made available soon.
