## **GRANTS**



U.S. Economic Development Administration's (EDA) *Build to Scale (B2S)* program Application Deadline: Oct. 28th. EDA invites organizations who support technology and innovation, especially high-growth companies to apply for \$5M which also includes startups - to develop, demonstrate, and utilize the next critical and emerging technologies.

#### Examples include:

- Building public and private capacity for entrepreneurs and innovators to invent, improve, and bring to market new products and services in critical, emerging, and transformative sectors and industries.
- Accelerating the growth of regional economies that are focused on industries of the future.
- Empowering communities to provide proof-of-concept and commercialization assistance to technology innovators and entrepreneurs.
- Equitably and inclusively increasing access to capital for technology-enabled entrepreneurs.

BRIC and FMA programs for the 2024 grant cycle. These programs are annual, competitive grants, that are not related to a declared disaster. The BRIC program aims to shift the federal focus away from reactive disaster spending towards research-supported, proactive investment in community resilience. BRIC projects can include shovel-ready construction projects aimed at mitigating the risk of natural hazards to public infrastructure, or plans/studies

to help develop future projects (*e.g.* called Capabilities & Capability Building proposals). BRIC projects include up to a 75% federal cost share, but higher federal cost shares may be available for communities who are considered economically disadvantaged. The Flood Mitigation Assistance (FMA) grant is available to eligible cities, towns or counties. The goal of this program is to reduce the risk of repetitive flood damage to structures currently insured under the National Flood Insurance Program (NFIP). This program mainly focuses on property elevations or acquisitions. FEMA has allocated \$800 million for FMA projects for this upcoming grant cycle.

For either program, the first step in beginning the application process is to submit a Letter of Interest (LOI). **LOI deadlines** are as follows:

· BRIC LOI Deadline: October 31, 2024 · FMA LOI Deadline: December 1, 2024

#### **Information on Submitting an LOI:**

- · Review of the NCEM BRIC2024 Notice of Funding Opportunity (NOFO)
- · Register for an account or login at the NCEM Salesforce Portal (tutorial included on weblink below).
- $\cdot$  Answer the 7 narrative questions on the LOI form in Sales force.
- · Upload 3 PowerPoint slides using the LOI Slide Template.
- · Upload 5 (optional) attachments to support your proposal.
- · Submit your LOI by the deadlines indicated above.

The focus of the LOI is to summarize your community's need/problem that the proposed project is expected to solve along with an explanation of the proposed work. You will also need to identify how nature-based solutions are being considered in the scope of work, and how the proposed project is being responsive to the effectives of climate change. The LOI must also indicate what populations within your community will be impacted, specifically focusing on any benefits to disadvantaged populations.

CDBG's 2024 Neighborhood Revitalization (CDBG-NR) Program Extended: Oct. 31st. Due to the impacts of Hurricane Helene and Potential Tropical Cyclone #8, the Rural Economic Development Division (REDD), NC Department of Commerce is extending its program.

The maximum grant amount is \$950,000 per grantee with some restrictions for specific activities. For the 2024 CDBG-NR round, projects that have or

are seeking Low-Income Housing Tax Credits and/or are restoring housing in storm impacted areas may be considered for up to \$5 M. Potential Applicants are encouraged to, first discuss their proposed project with the CDBG Director, Valerie D. Moore Fegans at <u>Valerie.fegans@commerce.nc.gov</u>, or CDBG Section Chief to confirm eligibility prior to the application deadline.

The CDBG-NR program is designed to provide grants to non-entitlement local governments for housing, housing-related activities, and public facilities. Approximately \$4.76 million of the \$12,292,736 available is set aside for the Rural Community Development Fund, which allows Tier 1 communities to submit non-housing projects as a sole activity.

**USDA's Emergency Watershed Protection (EWP) Program** offers a Post Disaster Assistance Alternative. Those who seek EWP assistance do not need to reside in an area that has been declared a national disaster, although they do require a city / county or conservation district project sponsor; the program provides help to eligible people and conserves natural

resources. NRCS may provide up to 75% for emergency construction; local sources may provide 25% in cash or in-kind services. Congressional approval must be conferred. - Deliver programs supporting a just transition for communities moving toward cleaner energy infrastructure.
- Support initiatives supporting upward mobility for families and individuals in the communities Duke Energy serves.
- Present programs reducing structural barriers and promoting access to opportunity for underserved communities.

US Department of Labor announces reintegration grant for Homeless **Veterans.** The intent of the Homeless Veterans' Reintegration Program (HVRP), is an employment-focused competitive Federal financial assistance program, is to enable America's Veterans to reach their full employment potential and obtain high-quality

career outcomes for Veterans experiencing and at risk of homelessness. The

Department encourages applicants to propose strategies to achieve economic prosperity, address historical inequities, and provide equitable access and outcomes to marginalized groups.

Eligible Applicants: (partial list) County, City or Town governments, Special district governments, Nonprofits/501(c)(3), Public Housing authorities. The program is entitled, Homeless Veterans' Reintegration Program (HVRP), Incarcerated Veterans' Transition Program (IVTP), and the Homeless Women Veterans' and Homeless Veterans with Children Reintegration Grant Program (HWVHVWC), but it is referred collectively as HVRP.

The Funding Opportunity Announcement was updated on Sept. 18th and currently continues to be developed. The <u>estimated deadline is April 12, 2025 by 11:59 PM</u>. Workforce Preparedness' priorities include:

- students earning at least one academic credential (curriculum diploma, certificate, or associate degree/con ed certificate) in the area funded.
- students earning at least one industry/third party certification, license, or other credential (nonacademic) in the area funded.
- high school students completing CTE pathways in the area funded.
- secondary or post-secondary students participating in work-based learning.
- secondary students receiving meaningful exposure and opportunities to explore local career opportunities.

Competitive project must focus on each of the Golden LEAF's 4 funding priorities to build capacity.

Annually, the Golden LEAF Board of Directors meets in February, April, June, August, October, and December. Applications are presented to the Golden LEAF Foundation Board at the next regularly scheduled meeting that is not less than 6 weeks after submission of the completed proposal. Occasionally, proposals may be submitted at an earlier Board meeting if Golden LEAF is able to complete its review prior to the meeting. **SAM.gov** will return to Grants.gov by the end of 2024. Annual registration for **SAM.gov** will become a baseline system requirement for submitting grant applications on **Grants.gov**. Reminder: The **SAM.gov** registration often takes several weeks to complete; immediately begin or renew the registration process.

**<u>HUD Updates Guidance - Environmental Review process.</u>** Below are the NC updates since July 2024:

<u>Coastal Barrier Resource System:</u> Modified reference to guidance for acquiring Flood Insurance Rates Map. Guidance is now under Flood Insurance.

<u>Endangered Species Act:</u> Added a link to reference the Region IV "U.S. Fish and Wildlife Service {USFWS} Clearance to proceed with Federally Insured Loan and Grant Project Requests."

<u>Noise Abatement and Control:</u> Added the equation for projecting traffic volumes for situations where a transportation department projection is not available and linear growth can be assumed.

<u>Wild and Scenic River:</u> Updated the guidance for adding Nationwide River Inventory Rivers to NEPAssist (EPA's web-based tool to determine environmental/demographic factors related to Environmental Justice).
