## "PLANNING AHEAD: A RESILIENCY AND INFRASTRUCTURE GRANT / PROJECT RESOURCE ROUNDTABLE"



The introduction, "Setting the Stage - aligning community needs with State and Federal funding priorities," was moderated by Jay Bender (Pollocksville Mayor). Panelists included: (L to R) Andy Fox (NCSU Coastal Dynamic Design Lab - College of Design), Holly White (NC Office of Recovery and Resiliency [NCORR]), and Vic Damato (NC Division of Water Infrastructure, Viable Utilities Unit).



ECC's Board Room was at capacity hosting the Roundtable, eighty-six registered for the 4 1/2-hour event, which offered a platform for state and local leaders to interact, sharing strategies and practices.



"From Vision to Implementation... to Revision" was moderated by Mackenzie Patak (Hometown Strong). Panelists included: Schumata Brown (Maysville Town Manager), Chris Suggs (Kinston Council Member), and Twig Rollins (Magnolia Town Manager).



Participants peppered Presenters with questions diving deeper into their topic area and their own municipality's resiliency needs, the Roundtable format had opportunities for individual follow up between public official and presenter.



Bob Taylor (NCDEQ, Viable Utilities Unit) led a participatory exercise, which included a grant project planning worksheet, the form is available at https://www.rebuild.nc.gov/ncresilient-communities-funding-forumgrant-project-planningworksheet/open.



"We have the funding. Do we have a project?" Moderator, Chris Baillie (NC Coastal Federation) and panelists Marquis Crews (NC Pandemic Recovery Office [NCPRO], NCOSMB) and Kaine Riggan, via Zoom (NCDPS, BRIC/FMA Lead) presented on their unique programs and provided helpful suggestions to improve future grant applications from the participants.



Andrea Webster (NCORR) presented the Resilience Exchange Tool - a versatile database to search vulnerability maps and the hazards that affect North Carolina, such as climate, severe weather, flooding, water quality, and many other topics. Seasonal change affects the results generated by the data, which are posted in real time during the search; numerous funding opportunities also are posted on the Resilience Exchange Tool. Moderator, Justin Nolan (Environmental Finance Center at UNC, School of Government) was heard saying, "Raleigh, we have a problem... unclear objectives, numerous challenges," other thought-provoking questions were responded to by Panelists: Bob Taylor, Kasen Wally (Division of Coastal Management, Resilient Coastal Communities), and Helene Wetherington (NCORR, FEMA Community Disaster Resilience Zones).



"Overview of Grant Writing / Administration Resources" was the day's final presentation. ECC's Holly Lippitt & Sara Deskar briefly spoke about their grant work. Holly provided a handout, citing specific Resilience Exchange opportunities and other resources (federal, state, and community foundations). Sara spoke about her outreach/ engagement role with FEMA's FMA Assistance Program. And Donald Hughes with Ania Hairston (NC League of Municipalities [NCLM]) spoke about the ARP Team's work.

The Division 3 NCDOT Public Meeting will be held on **July 8th from 4:00-6:00 PM** at the NCDOT Division 3 <u>Office</u>, which is located at 5501 Barbados Blvd., Castle Hayne, NC, 28429.

Follow these instructions to learn more about NCDOT's process.

1. Prepare for the public meeting, first, view the short, outreach video at https://youtu.be/zwW5YC6QMHU.

- Access NCDOT's MetroQuest website, after viewing the video, in readiness to provide public comments for STIP future planning consideration. Review the MetroQuest information at <u>https://www.ncdot.gov/initiatives-</u> policies/Transportation/stip/development/Pages/default.aspx.
- Follow the 2nd link, which remains open between June 17 and July 17, 2024, https://metroquestsurvey.com/oq8i8y, and add to the public comment.
- Watch for the NCOT STIP regional scores that will be announced later this summer. Somewhat later, projects will be prioritized within each Division for the 2026-2035 STIP.

In partnership with the International Economic Development Council (IEDC), ECC hosted a Talent Attraction & Retention workshop for members and other partners on June 25th. We had a wonderful workshop and discussion! Thank you to our presenters, all the participants, funding organizations, and partners.

Funding from the U.S. Economic Development Administration (EDA) and the Southeast Crescent Regional Commission supported this effort. IEDC members, Rhett Flood and Mike Chmura, provided the program. Rhett is Executive Director of Forge Young Talent, a young professional organization in Topeka, Kansas, focused on providing young people with the skills and resources needed to succeed in their careers. 
attraction and retention efforts.

#### ECC TO ASSIST COMMUNITIES WITH THE FEMA FLOOD MITIGATION ASSISTANCE PROGRAM

ECC Community Planner Sara Deskar recently began working with NC Department of Public Safety on ECC's FEMA Flood Mitigation Assistance (FMA) Program in a 2-year project to assist NC Emergency Management, local governments and property owners. In particular, Sara will assist jurisdictions with community engagement and constructing FMA Applications that will seek funding to assist homeowners that have been severely affected by flooding. The State has identified Eastern Carolina counties (Carteret, Craven, Duplin, Onslow, Pamlico, and Wayne) that have demonstrated high percentages of repetitive flood damaged properties covered by the National Flood Insurance Program. #### **ELDER ABUSE AWAREMNESS REGIONAL EVENTS**

Providers and community organizations held opportunities in their communities to promote dialogue and action on the issue of elder abuse, neglect, and exploitation. And providers across the region held events to include elder abuse awareness walks, presentations, Scam Jams, and informational fairs. Attendees were provided with information on elder abuse to include types of abuse, how to report abuse, current scam information, and how to prevent abuse.

ECCAAA staff delivered Elder Abuse Awareness "Be Kind to Your Elders" t-shirts throughout the region during Elder Abuse Awareness month. The t-shirts were given to children to promote being kind to your elders in collaboration with the region's NC Partnership for Children programs - and to help spread awareness.
