APPLY TO HOST A LEAD FOR NC FELLOW BY MARCH 8th – Lead for NC aims to create the next generation of local government leaders in North Carolina. The UNC, SOG program places recent college graduates in Full-Time, paid local government fellowships, to work on transformative community projects that are identified locally. It is a great way to build capacity and create a pipeline of future employees in local governments.

Every government partner receives a subsidy to alleviate its cost-share to contribute to the *Lead for NC* program. The most distressed communities will receive significant subsidies to hire a Full-Time fellow / employee to increase the capacity of their governments.

The deadline is March 8, 2024. FOLLOW-UP FROM DISASTER RECOVERY WORKSHOPS HELD IN THE FALL: As you may recall, the Eastern Carolina Council of Governments, in partnership with the Upper Coastal Plain Council of Governments, Working Landscapes, and Croatan Institute, hosted 3 workshops on October 23, 24, and 30 - to help communities identify and prioritize resiliency projects.

Local governments that participated have recently received a short, user-friendly report (via email and USPS mail) that summarizes their project plan ideas and provides targeted funding opportunity

recommendations and digital geospatial maps. These reports are designed to begin or continue a conversation about how to respond and prepare for your community's residents and infrastructure for future disasters. We encourage you to share this report with other government representatives, such as commissioners and relevant staff.

The facilitation team would also be happy to connect with participating communities over a 30-minute Zoom or phone call. This will be an opportunity to gain additional clarification about this report and strategize about next steps. This follow-up call will also be an opportunity for communities to learn more about funding opportunities relevant to their disaster resilience goals, as well as ideas on future collaborations with communities nearby.
