NC-DEQ Calling for Applications - Annual Weatherization
Assistance Program. The Department of Environmental Quality is accepting applications for community action agencies, non-profits, and public entities for its network of subgrantees for State Fiscal Year 2025-

2026 ('FY26). Eligible subgrantees install energy conservation measures in eligible low-income homes with the goal of reducing energy costs and carbon emissions. USDOJ-OVM announces Justice for Families Program Funding. The US Department of Justice, Office on Violence Against Women (OVM) announced the OVW 'FY 2025 Justice for Families Program, which provides justice and assistance for legal services. OVW is interested in funding projects that take a coordinated approach to helping families victimized by domestic violence, dating violence, sexual assault, and stalking as they navigate the justice system. To help achieve this coordinated approach, applicants may propose either a standard project or a

comprehensive project.

Funds under this program must be used for one or more of five statutory purpose areas as described below. Although the statute contains eight distinct purpose areas, OVW is limiting applicants to the following five purpose areas:

- (Purpose Area 1) Supervised visitation and safe exchange;
- (Purpose Area 3) Training for court-based and court-related personnel;
- (Purpose Area 5) Court and court-based programs and services;
- (Purpose Area 6) Civil legal assistance; and
- (Purpose Area 8) Training within the civil justice system.

Eligible applicants include county and local governments, as well as 501 (c)(3) non-profits. USDHHS-HRSA announces the Rural Health Care
Services Outreach Program. The US Department of
Health and Human Services, Health Resources and Services
Administration (HRSA) announced this community-based
grant program that supports organizations to promote rural

health care services outreach by improving/expanding the delivery of health care services and by adding new and enhanced rural services focused on strengthening local resources and capacity in rural communities.

Eligible applicants include local and county governments, organizations with a 501 (c)(3) tax designation, small businesses, and for-profit organizations. No match is required.

Each community is requested to develop innovative approaches to solve its own unique challenges and factors underlying rural health disparities by accessing collaborative consortiums of 3 or more health care providers. It is a technical, financial, and educational assistance program that delivers nature-based solutions to local and county governments and non-profits with a 501 (c)(3) tax designation. The grant (NOFO USDA-FS-UCF-012-2025) will focus on Sustainable Green Workforce Development for Disadvantaged Communities.

#### **USDA-NRCS** provides assistance for Natural

<u>Disasters.</u> USDA's Natural Resources Conservation Service (NRCS) administers the Emergency Watershed Protection (EWP) Program to respond to emergencies caused by natural disasters, although it is not necessary for a national emergency to be declared for an area to be eligible for assistance. The emergency recovery program is designed to

help people and conserve natural resources by relieving imminent hazards to life and property caused by floods, fires, windstorms, and other natural occurrences. All projects undertaken, except for the purchase of floodplain easements, must have a project sponsor. NRCS may bear up to 75 % of the construction cost of emergency measures. The remaining 25 % must come from local sources and can be in the form of cash or in-kind services. Funding is subject to Congressional approval.
