Regional Digital Inclusion Plan

As part of ECC's partnership with North Carolina State University's Institute for Emerging Issues (NCSU IEI) and the NCSU Friday Institute for Educational Innovation, a Regional Digital Inclusion Plan is being developed for the 9-county region.

A digital inclusion plan will support the region's efforts to increase broadband access and use, and computer literacy. Carteret, Duplin, and Onslow Counties already have digital inclusion plans in place and their data will be included in the 9-county regional plan.

Residents of Greene County participated in a Digital Inclusion plan listening session on Nov. 15th at

Greene County's Senior Center in Snow Hill. ECC held its 2nd Digital Inclusion Listening Session at Heartworks in Pamlico on Nov. 18th.

Regional Opioid Asset Mapping Project

All nine Eastern Carolina Council counties are collaborating with ECC to develop a regional, comprehensive assessment across the continuum of care for adult substance use disorder. The primary goal of the assessment map is to identify gaps that can be addressed through services in regional collaboration.

The Recovery Alliance Initiative (RAI) is an organization with whom ECC is partnering to bring sectors of communities together to explore opportunities for collaboration and solutions to address the opioid epidemic. We appreciate all 9 counties for supporting this effort, because together we will be better able to address the opioid crisis!

Magnolia Hires Charles Banks as Town Manager: ECC assisted the Town of Magnolia with its recent Town Manager search. ECC appreciated this opportunity to work with Mayor Dawn Ward and the Town Board, and we are excited to welcome Charles Banks to the ECC region as the Magnolia Town Manager.

NC Chapter of the American Planning Association - Senate Bill 382:

In an APA Email, the NC Chapter offered an Update on SB 382 that they opined would limit local government authority in zoning administration and community planning. Reportedly, last week, Governor Cooper vetoed Senate Bill 382. The Chapter's analysis identified these potential areas of interest:

- Retroactive applicability to decisions made six months in the past
- Conflicts with state requirements
- Impacts to extra territorial jurisdiction and voluntary annexation
- · Barriers to updating and amending land use regulations in response to community and market needs
- Unintended impacts to the zoning entitlements process
- Modifies local governments' ability to implement long-term planning strategies

The APA is committed to continuing coordination with the League of Municipalities and the Association of County Commissioners to advocate for sound planning practices and the protection of local authority. The Chapter's legislative committee will monitor the status of Senate Bill 382 when the Legislature reconvenes in December. (On December 2nd, the NC Senate voted to override the veto. It offered an opportunity to raise awareness of caregiving issues, educate communities, and increase support for caregivers. ECCAAA providers across the region hosted events to celebrate caregivers in our communities, which included the Wayne County

Caregiver Day Out event; Lenoir County Council on Aging Caregiver Candlelight Vigil; Duplin County Senior Services Caregiver Candlelight Vigil; caregiver support group celebrations; and many other events. Caregivers received information and resources to assist them in their caregiver roles. ECCAAA staff assembled and distributed 245 caregiver gifts for providers to celebrate their caregivers.
