**Two Eastern Carolina Counties Selected to Participate in an UNC Program to Address Affordable Housing Needs!** Congratulations to Jones and Carteret Counties who will participate in the *Our State, Our Homes* program with 22 other NC communities! More than half of the State's 100 counties applied to participate in the 18-month program in which strategies will be designed and implemented to improve access and the availability of affordable housing.

More than 1M households in NC are cost-burdened by housing and spend more than 30% of

their income on it. This includes nearly 1 in 5 homeowners and almost half of the State's renters. With a limited supply of affordable houses, rising costs, and other issues, community leaders are challenged to meet local needs for safe, accessible, and affordable housing.

Since housing is a multifaceted challenge, this pan-university program will bring together campus partners from a wide range of disciplines, including the UNC School of Government's Development Finance Initiative, the Department of City and Regional Planning, Kenan-Flagler Business School, and the UNC School of Medicine.

**Update on the Regional Opioid Mapping Asset Project** The ECC General Membership Board received an update on the Regional Opioid Asset Mapping Project during its Jan. 9th Meeting. All 9 counties in our region are collaborating with ECC to develop a comprehensive assessment across the continuum of care for adult substance use disorder. The primary regional goal is through collaboration to create an assessment map of the ECC region to be used to identify and address gaps. ECC is working with the Recovery Alliance Initiative (RAI) on this project; it is an organization that brings sectors of communities together to explore opportunities for collaboration and solutions to address the opioid epidemic. Stakeholders from the nine counties met on January 23rd to discuss the next steps, which include:

- Begin collecting data in February.
- Share preliminary results with county managers in late March.
- Present the final report to address the Opioid Crisis in June.

**Digital Inclusion Listening Sessions in Craven and Wayne Counties -** ECC will hold two more Digital Inclusion Plan Listening Sessions in the near future:

- Craven County February 26th
- Wayne County March 10th

This is a part of ECC's Digital Inclusion Plan project, in which ECC is partnering with North Carolina State University's Institute for Emerging Issues (NCSU IEI) and the NCSU Friday Institute for Educational Innovation to develop a Regional Digital Inclusion Plan for our ninecounty region.

A digital inclusion plan is a tool and resource for a community to assess who has the access and resources to utilize, broadband, the internet, computers, and all the resources that come along with that. Developing a digital inclusion plan will help support our local governments' efforts to identify gaps and help our communities develop plans to improve computer literacy and access. Input gathered through these listening sessions will provide better data to assist us in developing a plan that meets the true needs of our communities.

The discussion centered on community preparedness and strategies for building resilience in response to evolving climate risks. # ECC AREA ON AGING (AAA) NEWS



**North Carolina Senior Tar Heel Legislature:** The North Carolina Senior Tar Heel Legislature (NCSTHL) was created as a nonpartisan, unicameral body by the North Carolina General Assembly (NCGA) with the passage of Senate Bill 479 in July 1993. Each of the 100 NC counties is entitled to 1 delegate to the STHL; most counties have an alternate delegate. Delegates and alternates must be age 60 or older and reside in the county from which they represent.

The Senior Tar Heel Legislature was created to:

- Provide information to Senior citizens on the legislative process and matters being considered by the NCGA.
- Promote citizen involvement and advocacy concerning aging issues before the NCGA.
- Assess the legislative needs of older citizens by convening a forum modeled after the NCGA.
- Senior Tar Heel Legislators meet 3 times a year (March, June, and October), usually in Raleigh, to advocate on behalf of older persons. They have 4 officers: Speaker, Speaker Pro Tempore, Deputy Speaker Pro Tempore, and Secretary. Each year the legislators choose the top 5 legislative priorities. Delegates and alternates from each county advocate with the NCGA for the passage of legislation to improve the lives of older adults.

**Dementia Live Presentations:** ECCAAA staff provided Dementia Live large group, dementia, caregiver crisis, and Senior presentations to Lenoir County Police Officers on January 8th and Wayne County Law Enforcement on January 14th. The presentations were provided as part of the Crisis Intervention Training (CIT) curriculum. Participants participated in a hands-on simulation that provided them with empathy and understanding of what an individual with dementia may experience. Officers also learned about dissociation techniques for individuals - how to approach and work with older adults, elder abuse, and community resources. ECCAAA staff also will provide CIT training for Greene and Duplin County law enforcement in February, and Craven County's officers in March.

The Dementia Live Simulation training also was presented to facility volunteers at the NC Aquarium on January 29th.
