Call to Order – Kyle DeHaven, Chair TCC

Kyle DeHaven called the meeting to order at 9:39am, quorum was met.

5. ECRPO Staff Report – Jordan Kearney

Jordan Kearney discussed the need for the establishment of a SPOT Sub-Committee for the upcoming P8 Cycle. This committee will require one representative per county (Greene, Lenoir, Duplin, and Wayne), and a member from each NCDOT Division (2, 3, and 4).

Mickey Anderson stated that the committee will meet at least twice, and it could be held virtually. Jordan Kearney will send an email after the meeting to TCC and TAC

representatives to ask for volunteers for these positions. After members have been set, Jordan Kearney mentioned that the committee will convene to establish meeting dates and times, and to establish and update our methodology and goals.

Jordan Kearney also mentioned that there have been talks of the next prioritization cycle, P9, possibly requiring express designs for each project submitted. He stated that no action has been taken by the group at this time, but if approved, the TCC and TAC boards would have to convene for P9 early to discuss the necessary actions.

- i. Duplin County Update – *Angel Venecia*

Angel Venecia introduced Dawn Strickland, the new transportation director. Angel will continue to stay on the TCC, with Dawn Strickland as her alternate. Dawn Strickland gave an update, stating that they have received their new fleet of vans from FY22, FY23, and FY24, all at once, totaling 14 new vans. They noted that they have also moved their organization to a new building. Angel iterated that they have been improving their trips significantly, not being negatively impacted much since COVID-19, with overall ridership going up. They are set to exceed 44,000 trips this year. Angie asked Angel who used the public transit the most, with Angel saying that their biggest use includes medical services, with employment following that. Angel also said that they have a strong relationship with the local community college and their students, transporting 30 students a day.

- ii. Greene County Update – *Kim Howell*

Kim Howell stated that they have 3 new vans, with an expectation that in FY26 they will have a whole new fleet. They have also begun the grant writing process for FY27.

- iii. Lenoir County Update – *Angie Greene*

Angie Green says that more than half of their fleet has been replaced. They have also begun the grant writing process for FY27.

- iv. Wayne County Update – *Don Willis*

Don Willis said that GWTA provided free transportation for non-abled people to the recent airshow. He also noted that they have completed onboarding counts for their transit along with customer survey feedback and have received positive feedback from the public. He also noted that the Urban Busses have been replaced.

Gage King has said that he has replaced Rick Barks. He noted that the GTP has a total of \$400 million of projects ongoing. Some of the projects include the recently completed fueling system, an upgrade to their runway lighting system, and a new aviation school in conjunction with the Lenoir Community College.

iii. Wayne County Update – Mike Bass

7. Other Business

Mickey Anderson noted that Jordan Kearney recently graduated from ECU and will be transferring to a full-time position within ECCOG. Mickey noted that as Jordan is full-time, Mickey will be transferring his focus to the Down East RPO, with Jordan taking over the Eastern Carolina RPO. Mickey said that he will continue to take charge of Greene County CTP until it finishes, however he will be taking a backseat for ECRPO matters but will still be here if needed.

Mickey Anderson also mentioned a Transportation Workshop that is open to all members of the TCC and TAC for both RPO's, along with any official member. He is unsure if the public is invited but will figure that out. Mickey said that the theme of the workshop is going to be "How a Road Gets Built" from the CTP Process to the opening of the road. Along with the road process, a speaker will also give a presentation on the financial impacts of the recovery efforts that have been made by Hurricane Helene. He notes that this workshop is expected to be held between June and September but will confirm the dates later.

Summary:

With the upcoming submittal window for the Prioritization 8.0 (P8.0) Cycle, the SPOT Subcommittee finalized a draft list of projects for the Eastern Carolina RPO. This includes Highway and Bicycle & Pedestrian projects. Aviation projects were developed in coordination with the local airport authorities in our region. Rail projects were created or revised in collaboration with the NCDOT Rail Division. Public Transit projects were developed in coordination with the local transit agencies in our region.

Due to limited funding this cycle, the Prioritization Workgroup and NCDOT SPOT Office reduced all Planning Organization and Division submittal allotments by 30%. As a result, ECRPO's available slots per mode have decreased from 21 to 15.

Project selection was guided by public input, staff recommendations, Division and County priorities, and additional stakeholder feedback. The result is this Draft Project List for the P8.0 Cycle, which includes up to 15 projects per mode.

This list is subject to change prior to Final Approval.

Submitting this list marks the beginning of the prioritization process, where ECRPO Board-approved projects will be submitted for scoring and funding consideration. Upon TCC and TAC approval, the draft list will be released for public comment for a minimum of 30 days before returning for final approval.

Summary:

The P8.0 Workgroup and NCDOT have introduced a new requirement for the following P9.0 Prioritization Cycle: at least two-thirds of all highway project submittals must include an Express Design-level cost estimate or greater. This requirement is pending final approval by the NCDOT Board of Transportation. While some exemptions may apply, full guidance has not yet been released. More details are expected after staff attend an NCDOT training session on July 21.

Although we are currently in P8.0, we have been advised to submit an Express Design list during the P8.0 project submittal timeframe to allow the NCDOT Feasibility Studies Unit sufficient time to complete the necessary Express Design estimates before the start of P9.0.

ECRPO is expected to receive 10 Express Design slots. As a result, the number of highway project submittals that do not require an Express Design will be limited to the total submittal allotment given in P9.0, minus those 10 slots.

To prepare, the SPOT Subcommittee has recommended submitting the full P8.0 highway project list to NCDOT, along with any eligible P7.0 projects, in ranked order. Although ECRPO is limited to 10 express design slots, submitting the full list will allow additional projects to be reranked at a later date if needed.

This list is subject to change prior to Final Approval.

Upon TCC and TAC approval, the draft ECRPO P9.0 Express Design Project List will be released for public comment for a minimum of 30 days before returning for final approval.

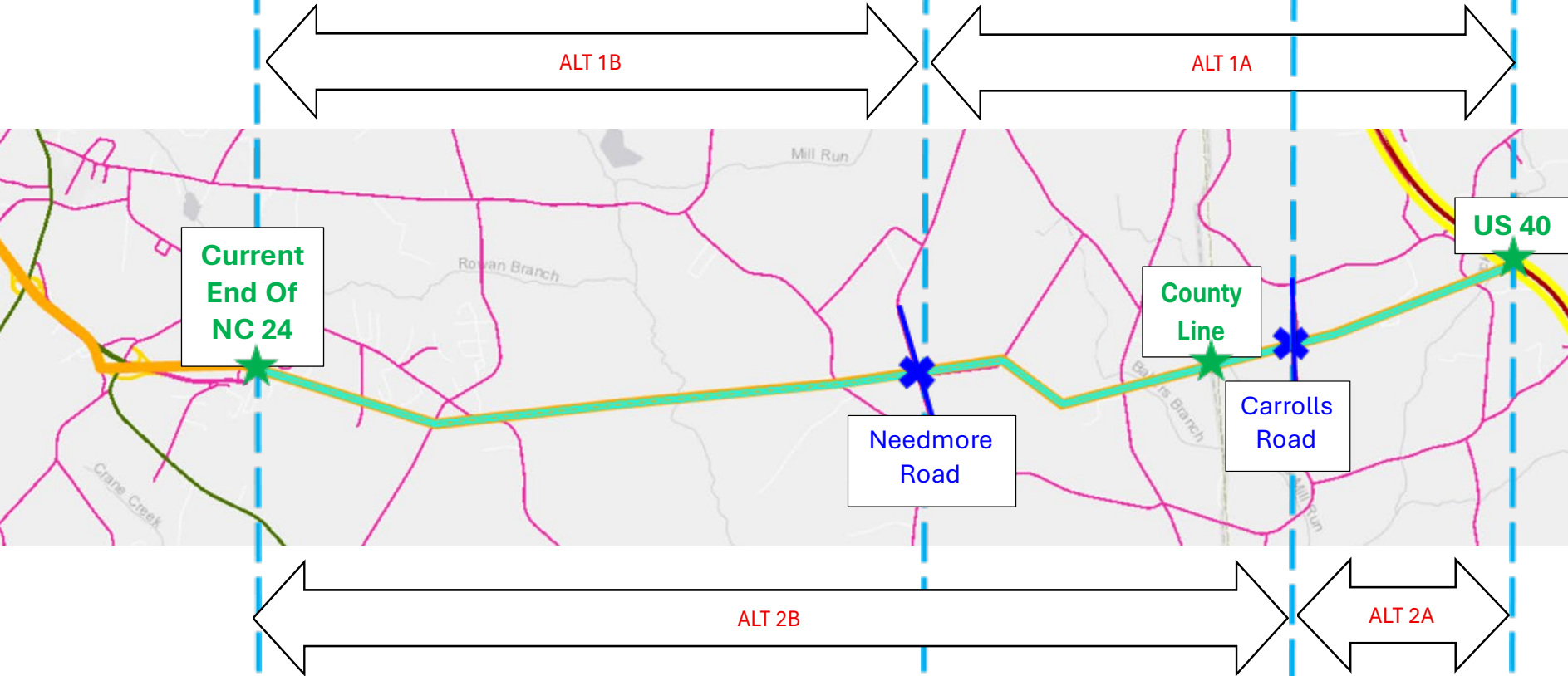
